**MOTION FOR ORDER DIRECTING DEFENDANT GARY DOUGLAS WARLICK
 TO APPEAR AND ANSWER AS TO ASSETS AND INJUNCTION FORBIDDING
 TRANSFER OR OTHER DISPOSITION OF PROPERTY**

Plaintiff, Oklahoma Department of Securities, moves the Court for an Order requiring the judgment debtor, Gary Douglas Warlick (Warlick), to appear with certain records on a date to be set by the Court and answer concerning his property and assets, and for an injunction enjoining Warlick from transferring, selling, concealing or otherwise disposing of any of his non-exempt property, pursuant to 12 O.S. § 842. In support of this motion, Plaintiff shows the Court as follows:

1. Plaintiff is a judgment creditor, having obtained judgment against Warlick in the above-entitled cause on June 2, 2017.

2. Warlick was ordered to pay restitution to any and all Tilapia Purchasers, Quail Purchasers, and Stock Purchasers, as defined in the petition, who purchased business opportunities and/or securities from the Defendants. The purchasers will be identified and the amounts to be paid to such persons will be determined by this Court. The restitution is currently unpaid.

3. Warlick is a resident of Washington County, Oklahoma, and is available for service in said county.

4. Pending a hearing on assets, there is a danger that Warlick will attempt to transfer, sell, conceal, and/or otherwise dispose of property in an attempt to place it beyond the reach of creditors, and this Court should enter an order enjoining Warlick from so doing.

WHEREFORE, Plaintiff prays as follows:


1. That this Court enter an order directing Warlick to appear and answer concerning his property and assets on a date to be set by this Court. That Warlick be further ordered to bring with him certain books, records and other matters in order that a full and complete hearing on assets can be held.

2. That this Court enter an order forthwith enjoining Warlick from transferring, selling, concealing or otherwise disposing of any non-exempt property pending a hearing on assets and until further order of this Court.
