MOTION FOR DEFAULT JUDGMENT AGAINST DEFENDANT
RANDY JAY DOUD

Plaintiff, Oklahoma Department of Securities, *ex rel.* Irving L. Faught, Administrator (Plaintiff), moves this Court to enter judgment by default in its favor and against Defendant Randy Jay Doud for the relief prayed for in the *Petition for Permanent Injunction and Other Relief* (Petition). In support of this motion, Plaintiff states as follows:

1. On February 28, 2017, the Petition was filed against Defendant.
2. On March 27, 2017, Defendant was served personally, by private process server, with the Summons and Petition.
3. Defendant has failed to appear and/or answer or otherwise plead to the Petition and the time for doing so has expired.
4. A copy of this motion will be sent to the Defendant upon filing.

WHEREFORE, Plaintiff prays that judgment by default be entered in its favor and against Defendants as follows :

I.

that Defendant be permanently enjoined from transacting business in and/or from the state of Oklahoma as an issuer, issuer agent, broker-dealer, broker-dealer agent, investment


adviser, and/or investment adviser representative or otherwise offering and/or selling securities in and/or from the state of Oklahoma;

II.

that Defendant be required to make restitution in a sum to be determined by this Court to any and all investors who purchased Okie limited liability company interests, a Money Metals Investment Contract, and/or an Investment Agreement from Doud, as defined in the Petition, and

III.

that a civil penalty be imposed against Defendant in the amount of Ten Thousand Dollars (\$10,000.00).
